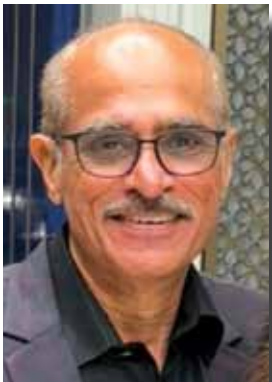

- 17.1 Members shall not canvass by distributing any printed or other material, pamphlets, slips or cards within or outside the Club premises and shall also not circulate any propaganda material to the members by any mode of communication, including electronic media such as e-mail, SMS, MMS and social media such as Facebook, Twitter, WhatsApp, etc
- 17.2 Guests and non voting members are not allowed during the Annual General Meeting day till the balloting is over.
- 17.3 Shall not organize mass transportation or conveyance to voters to attend the AGM and/or elections.
- 17.4 Shall not hold parties/get-togethers under any pretext, within the Club or outside, for soliciting votes or support.
- 17.5 Shall not canvas within or outside the Club premises on the day of the elections.
- 17.6 Shall not make telephone calls for canvassing purposes to any member who has registered for not being disturbed. The list of such members would be maintained by the Club in a “Do Not Disturb” Registry and made available to candidates and other members.
- 17.7 Members if found guilty of contravening the provisions of the Code of Conduct for Election as set forth above, shall face disciplinary action as thought fit by the Returning Officer and his Committee of Two other Past Presidents.
- 17.8 A brief resume and photograph of the contesting candidates shall be circulated by the office as a bulletin for information of members.
The Club may at its discretion hold a “Know Your Candidate” session at the Club premises to afford the candidates an opportunity to introduce themselves before the members. There shall not be any interaction with the candidates.

Note: The Chief Polling Officer will have the power to take necessary action in case of violation of Code of Conduct for Election.
